1. AGREEMENT

3. PRICING AND PAYMENT

- Prices are provided in quotations or may be listed on our website. Prices may change without notice due to market fluctuations or supplier changes. Agreed quotations will not be subject to these changes.
- Quotation prices are valid for 14 days from the date of issue.
- A breakdown of the applicable tax, shipping, delivery and handling fees are provided on the quotation.
- Payment is required at point of order for Stocked Items.
- \bullet Custom Orders: 50% upon order and remaining 50% due prior to delivery.
- Payment Methods: Bank transfer

4. ORDER CONFIRMATION

Upon receiving your order, we will send you an order confirmation. It is your responsibility to verify the order details, including quantities, product specifications, and delivery information. If any discrepancies are found, please notify us immediately.

5. DELIVERY AND SHIPPING

- The user will not commence delivery until all required information is received and payment has been made. Delays in these processes may affect delivery times.
- Bamboo Co is entitled to engage third parties for specific activities and deliveries required for the execution of the order.
